Meeting Minutes

March 30th, 2020

The regular scheduled meeting of the Lincoln Pipestone Rural Water (LPRW) System Board of Commissioners was held at the LPRW office in Lake Benton using WebEx video/teleconferencing on Monday, March 30th, 2020, starting at 10:12 am. Board Chair Mitch Kling conducted roll call for Member Commissioners at the start of the board meeting to establish a quorum with Commissioners Glen Grant, Bill Ufkin, Frank Engels, Jerry Lonneman, Joe Weber, Earl DeWilde, Randy Kraus, Brent Feikema, Rod Spronk, and Jan Moen present. A quorum was established. Also, in attendance was Board Attorney Ron Schramel, DGR Engineer Darin Schriever, Nathan Kinner (Kinner and Co.), Field Supervisor Tom Muller, General Manager Jason Overby, Enterprise Technician Jodi Greer and Lyon County Commissioner Rick Anderson.

- **Joint Powers Board Representative:** Lonneman reported that L&C bids for collector well were in, and very favorable. Ufkin inquired to Lonneman if L&C investments were considered as guaranteed insured.

Other Business: Lonneman expressed concern on COVID-19 and its affects to the livestock industry; anticipating shutdowns to livestock production plants and the cancellations of new livestock barn construction. GM Overby asked informal poll to Commissioners on this meetings platform (via video/phone conferencing), following proper Open Meeting Laws and Executive Order 20-20 for "Stay at Home" by the MN Governor. Overall, positive response given the situation. Ufkin suggested waiving late fees/penalties and suspending disconnects administered during the COVID-19 outbreak.

M/S Ufkin/Grant to waive late fees and penalties for the next three (3) months. Upon a roll call: Ayes-3 (Ufkin, Grant, Moen), Nays-7 (DeWilde, Engels, Feikema, Weber, Lonneman, Spronk, Kraus). Motion failed.

M/S Weber/DeWilde to suspend disconnects for three (3) months, but to continue administering late fees/penalties. Upon a roll call: Aye-10, Nay-0. Motion carried.

Public Comment: Lyon County Commissioner Rick Anderson provided update from Lyon County. All Lyon County facilities are closed to the public and the county landfill has been closed to the general public, excluding contract haulers. Legislature may consider suspending property taxes, but no decision has been made.
